Information Items

Board of Pensions: Art Mills, Regional Representative of the BOP gave a power point presentation on the benefits plan.

The Committee **voted to approve** dissolution of relationship between Rev. Gary Hindman and First Presbyterian Church, Upland, effective June 30, 2008.

That Presbytery approve the request of Church of the Valley, Apple Valley to temporary change the terms of call for Rev. Becky Sage to $\frac{3}{4}$ time with proportionate decrease in salary, effective February 1, 2008.

That Presbytery approve the change of call for Dave Loleng to be compensated for a sabbatical, to include vacation and study leave (120 days), from May 1 through August, 2008.

That Presbytery vacate the pastoral position for Redlands Community Church effective January 1, 2008 for pension purposes.

That Presbytery approve the position description for CLP Jan Opdyke, Redlands Community Presbyterian Church at the following terms:

Half –time position with 31 days vacation plus two weeks study leave
Compensation \$1998/month, housing allowance; no benefits package or social security
Travel reimbursement at presbytery rate effective January 1, 2008 through March 31, 2009.
