I-15 or I-215 (toward Barstow) to Hwy. 18 ("D" Street in Victorville); turn east (about 6 miles) to Dale Evans Parkway; turn left and a quick right onto access road; church is about ½ mile.

I-10 to Beaumont Avenue exit; north to Seventh Street, left about one block to the church on the corner of Euclid and Seventh.

From the West: Hwy. 30 to Running Springs; Hwy. 18 to Big Bear (becomes Village Drive); continue through the Village past Pine Knot to Knickerbocker; turn left to church on the right (just past the school).

From the East: I-10 to Hwy. 330 to Running Springs; continue on Hwy. 18 to Big Bear as above.

From Hemet: Hwy. 74 (Florida Avenue) east to Mountain Center; turn left on Hwy. 243; continue about 4 miles to Idyllwild.
